NIH DATA MANAGEMENT & SHARING POLICY

NIH's new Data Management and Sharing (DMS) Policy becomes effective January 25, 2023.

The new policy requires ALL grant applications and renewals that generate scientific data to include a data management and sharing plan (DMSP) as well as budget requests for data management activities when applicable.

This policy differs from the previous 2003 policy which only required grants of \$500,000 per year or more in direct costs to provide a brief explanation of how and when data resulting from the grant would be shared.

NIH BIOSKETCH FORMATTING

NIH biosketches have changed! The most significant changes include:

- The removal of Section D
- Section B is now named "Positions, Scientific Appointments and Honors"
- Section B should be split in two subsections: "Positions and Scientific appointments" and "Honors"
- All of Section B is now listed in reverse chronological order

LESS ISN'T ALWAYS MORE...

During some of our recent RPPR reviews we've seen quite a few occurrences of key personnel having reduced effort from the effort which was proposed. That is usually permissible without prior approval if the reduction of effort isn't 25% or greater and they aren't specifically listed as key personnel in the Notice of Award (NOA). However, specifically with the National Cancer Institute (NCI), there are required minimum efforts for PI's or Program Project leaders and there can be no reduction of effort below the minimums. We have had to correct some reductions that went below the NCI minimums prior to submission of the RPPR.



To ensure effort meets the NCI minimum levels, visit ORSS Research Links or NIH's Notice of Information.

HAVE YOU EVER NOTICED....

That some F&A charges end up hitting PROG-CREF 0000-0000?

This occurs because one aspect of the 26 digit account combination doesn't have a matching account code combination set up in PennERA for direct expenditures that were charged. So, if you ever see this occurring it could be there is a wayward charge, transposition error, or perhaps you didn't request a subaccount for intended charges. Ideally, we never want to see F&A getting charged to PROGCREF 0000-0000. While it might not impact the total charges on the grant fund, it does affect reports for subaccounts and helps identify F&A matched to each faculty via the CREF.
